Councillors reminded to fulfil their administrative requirements and sign the attendance sheet for the monthly remuneration associated with this meeting.

Mayor thanked all present for their attendance and welcomed everyone to the meeting. Acknowledgements made to members not present and respect was paid to the Traditional Owners of the land on which we meet, to the elders past and present, to the councillors and employees present for the meeting. CEO advised that Council have permission from OMAC to remove infrastructure from Janey Creek. We will be going to Janey Creek in the next few weeks to commence the removal process.

Andrew Kerr advised Council that he has limited knowledge of what was there originally. We don't want to touch infrastructure that doesn't belong to Council.

Mayor Addo advised that the Sport & Recreation implementation plan has been finalised.

CEO has made comment and sent the document, waiting for finalisation.

Mayor Addo requested an official opening date for the Visitor Accommodation.

CEO: Council can decide whether to nominate a date in next few weeks or wait until early next year. We have a busy few weeks coming up.

Cr. Guivarra enquired whether Council are relying on a federal MLA coming to do the official opening.

Mayor Addo advised Warren Entsche is happy to come back and participate in the opening.

CEO suggested the 3<sup>rd</sup> week of January.

Mokwiri have been invited to today's meeting to talk to Council about the Mapoon DOGIT.

- 9.15am CEO departed the meeting
- 9.16am CEO re-joined the meeting
- 9.16am Mokwiri joined the meeting, welcomed by Mayor Addo.

Charles Budby thanked Council and introduced Gail Budby from the Mokwiri administration office and Rhonda Parry as a Director. Charles spoke on behalf of the PBC advising that Mokwiri have signed up with CYNRM. Cape York partnership have set up something similar. CYNRM look after ecology, river systems and so forth. We think this is a good move. Janey Creek, has been discussed with solicitors and we can't do an ILUA until OMAC and Tjunginji are consulted. Mokwiri don't represent one family with the ILUA, there are cultural heritage environmental issues. In saying that, we need to progress the Mapoon waste landfill site.

Preferable to have this solved by early next year. We hope to bring interested parties together, under management that is environmentally friendly.

Cr. Guivarra advised that the ILUA for Janey Creek is with the Tjuninji people.

Charles Budby informed Council of the 2 types of ILUA's, in this case it is business. Mokwiri's position is that there is room for business ILUA's. OMAC has never had to deal with this before. They have not demonstrated compliance as yet.

Mayor Addo enquired whether or not TO's needed an ILUA.

Charles Budby advised that if it is a profit-making business they will require one for insurance, public liability purposes etc. This is different to the waste facility that is in the process of being signed off.

9.29am Councillor Brown departed the meeting.

Question from Mayor Addo regarding recognition for people adopted into Traditional Owner families. Charles Budby advised Council there are 2 types of adoption, we have never made a decision as yet, but we would err on the side of cultural/traditional adoption.

Mayor Addo enquired if Mokwiri will take steps to tell the occupants of Janey Creek that they cannot operate their business from Janey Creek.

Charles Budby stated: Yes, Mokwiri's solicitors have told them that they cannot continue.

Mayor Addo: What is their response?

Charles Budby advised that the occupants maintain that they are there at the invitation of the family. One of the family members is a director of Mokwiri

Gail Budby commented that Mokwiri has been dragged into this.

9.34am Councillor Brown re-joined the meeting.

Gail Budby continued: Mokwiri has had nothing to do with this, OMAC are the ones responsible for it. Cr: Smith: Isn't Mokwiri there for the people? You are saying that OMAC created a situation. Do you know the

history of what happened?

Mayor Addo request Cr. Smith leave the meeting. 9.36am Cr. Smith departed the meeting.

Charles Budby advised that Mokwiri are unable to process any ILUA's until the correct process is in place. We have said we will not issue an ILUA unless it is to TO's.

CEO: Council agree with that.

Mayor Addo advised that Council have infrastructure that we have to deal with under the Act.

Charles Budby: We have had similar issues with other councils. We are trying to encourage businesses to progress.

Mayor Addo: Council agree with that.

Charles Budby: Mokwiri are in negotiation with Napranum Council for the DOGIT

Mayor Addo: Is it the town area or just outside?

Charles Budby: Just the outside. Mayor Addo: Who will be the trustee? Charles Budby: It will be the Council.

9.45am Councillor Brown departed the meeting.

Charles Budby advised that Mokwiri would like to participate in the meetings with Rugupayn to discuss the ILUA. In 2020 the ILUA is up for renewal. With support from MASC, Mokwiri intends to apply to the State and Federal Government for control of the Ranger programs. There is also transitioning with Mypathway for the CDP program, Outstation development.

Gail Budby thanked Council for the invitation.

Rhonda Parry offered suggestion for naming Paanja Lodge: Manatua was one of the first TO's of this region.

Mayor Addo thanked Rhonda and advised that we will get back to you in the new year.
