• Transitioning of Mapoon health services – Mapoon need skilled people with capacity. Wait for transition until neighbouring Councils

Cr. Guivarra enquired whether Aurukun had the right pilot.

The Mayor commented that some Indigenous Communities were experiencing issues, Coen and Napranum stand alone, the transition should have commenced in Mapoon. It was greed to 14 years ago. For GP services or health workers and administration of medication, Apunipima can look after this. There are currently three people working in Apunipima who are unskilled.

Planning for Paanja: the festival turned out really well. Do we want to have it every 2 years?
 Council were not happy with the amount of money paid for a coordinator. Social Media has provided positive feedback.

Cr. Smith commented that the people who came really loved it. The contemporary band Forever road were fantastic.

Need to decide whether it needs to be alcohol free, Mornington Island had a licence and it worked with a designated area for drinking.

CEO Ms. Naseem Chetty invited to speak on her report for October.

The Paanja Festival: Some hiccups unbeknown to the general public. Living proof how the community can pull together to achieve a common goal. Stakeholder feedback is positive.

Record attendance, Tjungunji opening ceremony attended by 700 people, commitment to their culture, pledge support for the next Paanja festival, acknowledgement for some future projects.

Café handover: Wild Cape will have discussions with Council the contract will be signed once the hand over is completed.

The Visitor accommodation has been given practical completion and is open for bookings. We have received our first booking.

Mayor Addo: is there going to be an official opening? MP Entsche willing to come back and open facility.

CEO advised we are still looking for a name for the visitor accommodation.

Cr. Brown: Put it out to the community;

Cr. Smith: Put it out to community see what comes back council have the last say.

CEO: Janey Creek, still have not heard from OMAC whether they want to purchase the infrastructure.

Mayor Addo: Council resolved to write to the minister requesting to gift to OMAC. Prior to writing to minister find out whether OMAC want it or not. Should we retrieve the pump?

Works manager: We just purchased new pump \$5k. can have existing pump serviced.

CEO: OMAC have not gotten back to us, perhaps communication is not reaching OMAC directors. We should approach directors to meet with Council. If they don't want the infrastructure offer to Mokwiri.

Mayor Addo: We need to explore our 3 options.

Works Manager: public liability risk sits with Council. Cr. Brown: Can it be gifted to TO's as business operators? CEO No. We can gift to any non for profit organisation.

Mayor Addo: We need to deal with this matter before it ends up in court. Council need to make a decision.

CEO: We can organise meeting with OMAC, can coincide with trustee meeting on 23rd.

Cr. Smith: Were they supposed to move out of Janey Creek on Friday?

Mayor Addo: They were told to vacate the premises, they are not moving out, there are semi-trailers with building material and equipment; roller doors, scaffold. Permission given from Cooktown family. OMAC are the Land owner and need to provide consent.

Cr. Smith: Cooktowns are receiving advice with Mokwiri.

Cr. Brown: Have we tried to remove the occupants of Janey Creek from there?

CEO: No it was OMAC and they need Mokwiri support.

Cr. Guivarra: Should we provide a compelling case for them not to use the facility?

Mayor Addo: give them 14 days' notice and we will remove access to our bore.

The water at Janey creek is not treated and not maintained. The risk we are taking is immense.

The demand on the water supply has increased.

Cr. Smith: We have informed them we are covered.

CEO: No we have not, I have received legal advice.

Mayor Addo: We are councillors, we make decisions on the best interests of this community.

Cr. Brown: People come in and do things on a handshake

Cr. Guivarra: I am not against the Cooktowns. We are meeting with them on Tuesday.

CEO: We should be informing OMAC.
