6.1 MAYOR'S REPORT

PURPOSE OF REPORT

To advise Council of Councillor's Meeting Attendances and Portfolio Information

Mayor Addo: I spoke to Warren Entsch during his visit to Mapoon last week. He confirmed we will get the money required

Mayor Addo: There are people coming out for parole that are not from this Community.

Discussion about people and visitors in the Community.

CEO left the room to attend a matter 9.32am.

Mayor Addo: I have been told that the Angau Hospital in Papua New Guinea has been completed. They are starting to get COVID cases close to the Strait.

Discussion about COVID19 coming through Papua New Guinea to Queensland.

CEO Returned to the meeting 9.34am.

Discussion re the difference between the Torres Strait, and the outer islands.

Discussion re confidence in Qld health

Mayor Addo: I have confidence in Qld Health. They will do the right thing.

At 9:39am, Cr Daphne De Jersey left the meeting.

Further discussion about COVID19 and how the Community needs to take care and look after themselves.

At 9:41am, Cr Daphne de Jersey returned to the meeting.

Mayor Addo: I have been talking to MOKWIRI about a hydroponics area for Mapoon.

Cr Dawn Braun: It needs to be managed properly for it to work.

Discussion about hydroponics and market gardening at Mapoon.

Mayor Addo: Needs a proposal but we haven't received anything yet.

CEO- There is no land available.

Mayor Addo: They need to put it in a proposal.

Cr Margaret Mara: Are they looking to get a bigger area?

Mayor Addo: They need to work it out and make the right APLLICATIONS. We are waiting for a proposal first as there will need to be approval form Rugupyne. They need to work it out and get along.

Discussion about process for getting approval.

Mayor Addo: Talked to Noelene CEO for Apunipima about the Cape and surrounds.

Mayor Addo: I had a meeting with Weipa Hospital. There are concerns about calling 000 out in Mapoon as the Clinic is not getting staff for callouts.

Mayor Addo: There was a letter written. Nurses don't feel safe getting called out without a driver. It's in their PD, but nurses don't want to do it.

Discussion about safety for nurses.

Mayor Addo: If you call 000, the nurse has to wait for a driver to come out from Weipa and that could take at least 1.25 hours to come out and this is not a good thing in an emergency situation where time is vital in some cases.

Mayor Addo: Why don't the parents have Panadol for their children? Eery household with children should have it.

Cr Dawn Braun: Because it's at the clinic.

Mayor Addo: They should have the medication at home. This is a health issue, not Council's but still a community issue.

Discussion about getting drivers to work after hours on call at the Clinic.

Mayor Addo: Action item.

Can we get casual ambulance drivers from Council staff? If we get enough numbers, we can have some help out.

Cr Daphne de Jersey: There are several that are given a roster but they don't turn up.

CEO- We could send out a memo asking staff if they want to go to the Clinic to be a call out driver.

Mayor Addo: They were also asking about accommodation and if we have any available. Who is going into the new accommodation?

CEO- We have ours earmarked for expanding Council Staff.

Cr Margaret Mara: We can't give them ours, we need it.

Cr Dawn Braun: We could rent a cabin to them.

CEO- We could come to an arrangement. \$50,000 for 12 months.

Mayor Addo: They won't pay that much.

CEO- That's at a reduced price. It would be much more at full price.

Further discussion about accommodation around Mapoon.

Mayor Addo: I went to the TCICA meeting. We spoke about the virus and 24JAA. One area has had to return \$34 million as they couldn't get agreement with the Traditional Owners.

Cr Dawn Braun: If you apply, do you get the funding?

Mayor Addo: Can't get Federal funding. When Polly and I were on the board, we said that those houses needed to go up. State lodged the forms, went to the Minister. As soon as signed, we were told to go ahead. It's important infrastructure.

Cr Dawn Braun: If the Council says yes and the Trustee says no, what happens then?

Mayor Addo: Rugupyne Traditional Owners needs to sign approval.

CEO- If Rugupyne don't sign it, we then need to use the 24JAA.

Mayor Addo: Anything critical can go through the process. 24JAA was bought in as houses were not being built and there were issues with land tenure.

Cr Daphne de Jersey: It's been in for 10 years nearly?

Mayor Addo: There was a meeting about 24JAA and it was extended for another 12 months. It's needed if negotiations break down.

Mayor Addo: I have seen the houses at New Mapoon. They are very nice.

Cr Daphne de Jersey: Very tall too.

CEO through the chair. We need to make sure we get funding in little amounts so that we don't have to return funds.

Mayor Addo: Other Councils tend to ask for too much money.

Cr Dawn Braun: Warren Entsch said we are going ahead in leaps and bounds.

Cr Dawn Braun: We get comments from visitors saying how beautiful Mapoon is, but I had family tell me that the garden lights aren't working at night.

Action item: Organise for the lights to be working again.

Cr Daphne de Jersey: The gardens need a good watering too.

Action item: Organise for the garden beds to be watered.
