Mr Andrew Kerr from Preston Law attended the meeting and presented council with copies of the Mapoon Township Community Development Indigenous Land Use Agreement between MASC Mokwiri Aboriginal Corporation, Alwyn Peter, Cameron Hudson, Maggie Peter, Sandy Parry, Stephen Parry, Lizzie Clermont, Josephine Samson-Narara, Vanessa Reardon, Troy Reardon, Lottie Luff, Florence Luff and Harriet Flinders on their own and on behalf of the Traditional owners and the State of Queensland.

Councillors agreed with the terms of the agreement as negotiated and recognise this as a momentous occasion and reflective of the aspiration of the Mapoon people.
